Chair Fuller moved and Member Scotland seconded, and it was unanimously voted to open the Millis Board of Health meeting of November 14, 2022 at 6:06 PM.

Administrative Business:

- a. At 6:06 PM the meeting minutes for September 19, 2022, October 17, 2022, and the hearing for October 3, 2022 were not approved and was unanimously agreed upon by all board members to review at the next meeting.
- b. The monthly report of the Public Health Nurse

6:30 PM - CoVid/Flu update:

Director McVeigh, along with Public Health Nurse Ward, updated the Board on CoVid concerning the Town of Millis, Massachusetts. For October there were 34 confirmed cases of CoVid and an additional 15 confirmed cases of CoVid since the first of November in Millis. The CDC has reported Norfolk County, which includes Millis, at a low-risk level for CoVid. The mobile CoVid Booster clinic was held on October 26th, 2022 from 2 PM to 7 PM at the Veteran's Memorial Building (VMB) gym at which 50 people received their bivalent booster. There have been 128 flu vaccines administered to date.

6:36 PM – Bella Bela Aesthetics, LLC – Cosmetic Tattoo:

Luene De Oliveira representing Bella Bela Aesthetics, LLC is seeking to obtain an establishment and practitioner's license for cosmetic tattoos. The Board of Health members reviewed Luene hours for instructional (16) and apprenticeship (100) hours as well as the number of models (12) Luene has practiced on. The BOH regulations for cosmetic tattoos are substantially higher for instructional (100) and apprenticeship (200) hours as well as the number of models (50). Based on this large discrepancy, the BOH unanimously voted to not allow a practitioner license at this time.

The issue of insurance and the National Sanitation Foundation (NSF) rating on the portable sink was discussed. Currently, Luene does not have any insurance as a practitioner and would need to acquire liability insurance based on our regulations.

John McVeigh is to follow up with the Town of Wellesley to make sure that Jessica Hellen of House of Beauty is a licensed business in their town as well as calling J. Helen Academy to verify the hours Luene presented above for Instructional, apprenticeship, and number of models worked on.
