Jerry Burke, owner of 50 Richardson Drive put in a nuisance complaint over the dust level from the sorting of dirt piles across the street from his home. Initial inspection from Public Health Director McVeigh witnessed a nuisance violation. A warning notice was sent to Toll Brothers to mitigate the dust levels. Toll Brothers after receiving the warning notice took steps to mitigate the dust issues including routine sweeping and watering. Jerry Burke at the meeting acknowledged that mitigation was put into place but would now like something done about the noise level from the equipment and the pile of dirt moved to another location on site. The Board of Health has asked Toll Brothers to come up with a solution for moving the dirt pile sooner than later and to present a solution at the next Board meeting.
