**7:12 PM Discussion Covid/Flu update:**

Director McVeigh along with the Public Health Nurse Ward updated the Board on CoVid concerning the Town of Millis Massachusetts. Cases and hospitalizations are decreasing in the State. The schools have recently updated so that asymptomatic close contacts, regardless of vaccination status, do not need to quarantine at home if they are able to wear a mask. Public Health Nurse Ward said that she has ordered 1400 CoVid boxes that have 2 tests per box for distribution for the town. Plans for distribution would be starting with high-risk communities such as Council on Aging and senior housing and then going from there.

**7:28 PM BOH Office Service Counter:**

Director McVeigh along with Clerk Heather Graham presented and requested the approval of the Board to have a service counter installed in the BOH office. All Members approved counter and will use other spaces in Town Hall for monthly meetings.

**Plastics** – Director McVeigh updated the Board on letters sent to businesses that were noncompliant. Roche Bros has complied after Memorial Day; Tangerini's Farm is working on a solution for their produce and Tractor Supply is using paper with reusable bags available for \$1.00 by August 2022.

**Article against Tresca** – Tresca is under state review for air quality has 30 days to comply with DEP.
