326 ORCHARD STREET – PETER TEMPLE**

The public hearing continuation was opened at 7:38 p.m. by Mr. Chisholm, Acting Vice Chair.

Mr. Merrikin, representing the applicant, presented the revised proposed site project plan for construction of a driveway for a future single-family residential dwelling. The mathematical description of the proposed driveway centerline was added, as well as the proposed headwall and concrete apron at either end of the driveway culvert pipes. A DEP file number was assigned by DEP and there were no comments from them.

**REQUEST FOR DETERMINATION OF APPLICABILITY, PUBLIC HEARING
TOWN PAVING OF MIDDLESEX ST.
DPW – JAMES MCKAY**

The public hearing was opened at 7:51 p.m. by Ms. Rich, Acting Chair.

Mr. McKay presented the application for paving of Middlesex Street from Ridge Street to Brookview Road. Mr. McKay stated that they expect the work to be done in July/August and that “silt sacks” for erosion control will be in place at the bridge and 100 feet in either direction.

On a motion made by Mr. Chisholm, seconded by Mr. Lee, it was voted unanimously at 8:01 p.m. to close the public hearing.

On a motion made by Mr. Chisholm, seconded by Mr. Lee, it was voted unanimously to approve a Negative 3 Determination of Applicability with a special condition to provide erosion control along both sides of the roadway within 100 feet of the brook bank.
