PLEASANT STREET PARK – DISCUSSION THOMAS DOWNS, 178 PLEASANT STREET

UNION ST./RIDGE ST. YARD WASTE DUMPING – INFORMAL DISCUSSION THOMAS CUSACK, 438 UNION STREET

Mr. Cusack requested an Informal Discussion with the Commission for clarification on "Conservation land" or "wetlands" near his property and that of his neighbors. Mr. Cusack expressed concerns over neighbors dumping yard waste/lawn debris/leaves, etc. into a potential "wetlands" area. He is worried about potential problems in the spring with mosquitos due to all the wet leaves.

After reviewing mapping in the area, the Commission determined that there were no wetlands in the area in question. The Conservation Commission has no jurisdiction for the area in question. The Commission thanked Mr. Cusack for coming into the meeting.

OTHER BUSINESS:

140 CAUSEWAY STREET – WINDY KNOB FARM, LLC "FOREST CUTTING PLAN" - J. CLARKE, FORESTER – EMAIL

In response to Mr. Clarke's email, the Commission was just inquiring, for their information, how they were going to construct the temporary crossings to get the forestry machines in there. Within one year, the crossings have to be removed.

CUTTING OF VEGETATION AT REGENCY AT GLEN ELLEN

The Conservation Commission was made aware that there was unpermitted cutting of vegetation for a second time at the pond on-site. This action is a violation of the Massachusetts Wetlands Protection Act and the Town of Millis Wetlands Bylaw. It was further observed that the cuttings/debris were left in the pond.

On a motion made by Mr. Chisholm, seconded by Ms. Gavin, it was voted unanimously, with Mr. Steadman and Mr. Larsen recused, to issue an Enforcement Order to the Regency at Glen Ellen Condominium Trust (Attn: Jack Donahue) for unpermitted cutting of vegetation along the

bank of the large pond on-site. A restoration plan shall be filed with the Commission on or before March 15, 2024, for:

- Restoring plantings with native wetland species and a written plan to prevent future violations.
- All cuttings/debris must be removed from the pond.
- Attendance at the March 18, 2024, Conservation Commission meeting is required.

APPROVAL OF FY2025 CONSERVATION COMMISSION BUDGET

On a motion made by Mr. Steadman, seconded by Mr. Chisholm, the FY2025 Conservation Commission budget was unanimously approved as written.

TREE REGULATIONS/BYLAW - DISCUSSION

Commission members Mr. Steadman and Mr. Larsen, as residents of Regency at Glen Ellen, would like approval and authorization to discuss and vote on any matters related to Regency at Glen Ellen that come before the Commission. The disclosure letters outline the nature of any potential conflicts and the steps they intend to take to mitigate any undue influence on their decision-making process regarding the Regency at Glen Ellen development.

As the Select Board is the appointing authority for the Conservation Commission, they will have to approve such requests.

On a motion made by Ms. Hayes, seconded by Dr. Lederer, it was voted unanimously to recommend the approval of the letters by the Select Board. Voting on the motion were Dr. Lederer, Ms. Hayes, Mr. Chisholm, Ms. Gavin, and Mr. McPhee.
