### **New Business:**

- Middlesex Bank has been invited to attend the dedication of the new exercise room on 6/28 at 11 amcable will stream the event. Judy O'Gara has also been invited for the ribbon cutting. A healthful brunch will be offered (vegi dip, fruit bowl, coffee and tea)
- Summer events:
  - 1. Photography class will be offered by Steve McGrath the cost to the COA will be \$70.00 which Patty will ask the Friends to cover
  - 2. The new nutrition counselor, Stephanie from HESSCO will offer free counselling classes on the second Thursday of the month.

- The Fitness Room discussion. As Enhance Fitness sponsored by the YMCA charges \$100.00 for 16 week sessions Patty proposes that a charge of \$100.00 per year by charged for the use of the Fitness Equipment. The equipment must be maintained 2 times per year at a cost of \$520.00 for maintenance.

  - 1. Millis Seniors should NOT have to pay for room usage proposed by Mary Skilling
  - 2. Nancy claims she has contacted other centers (Dedham, Dover, Hopkinton, Norwood, Natick, Medway) and no one charges
  - 3. Concern about a locked room what if someone using the equipment falls or has a medical concern?
  - 4. Security camera was suggested.
- When the Fitness Group was excused the Board discussed breaking the fee into (2) \$50.00 payments every 6 months and anyone receiving LIHEAP or fuel assistance would be allowed to go free. Patty sights a bookkeeping problem Helen and Bert offered to help with that.
