## **New Business**

- Unanimous approval of minutes from both the Special meetings on 7/20 and 7/30
- Patty advises that she has been investigating the use of ROBO calls to advertise special events being held at the COA. We already have access that we pay \$1K per year for but we can sign up to use the

- COA tel number and COA address for an additional \$300 per year. She feels that this will be very useful now in the time of Covid. Board unanimously approved her asking the Friends to cover the cost of \$300 for one year
- Mailing List Helen had volunteered to update our mailing list and with the help of Kathi Smith in the Town Clerk's office it was updated removing those who have died and moved out of town. Our previous number sent was 1538 now reduced by approx. 23
- Bills payable need to be signed Bert, Elizabeth and Helen will meet Patty at 'VMB this morning to sign
- Bert, Elizabeth, Chris and Helen will prepare Newsletter for mailing on Monday they will bring to Chris's house on Friday for her to take to Patty on Monday

## Special Meeting of 7/30 discussion

- Patty summarized survey and sent info to Diane who will review with Wayne she is waiting for a response from them
- Bert's concern is we need to be open 8 hrs per day, 5 days per week we need more staffing hours to accomplish this
- Patty says that we will need a Program Director in order to be able to accomplish all the offerings we would like to make. She feels that the realization of a new Center will probably be up to 7 years down the road, especially now with the Covid problems we're dealing with
- Chris offered the process the Library went through in the years before they were funded important to keep the process in the public view she also noted that with the Covid problem it will probably not be a good idea to bring this forward at the November Town Meeting perhaps best to wait until May
- Bert's question is Who decides to take it Town Meeting? The Permanent Building Committee?
- Chris asked have we the COA Board- decided on s site?
- Helen noted that going back over what if's will bring us nowhere looking back over the years to St. Paul's, the parking lot land at Clyde Brown and the Clyde Brown School itself making space for the Senior Center in their new building opportunities that have passed us by we must keep the need in the public eye and involve as many towns people in the decision making process so that they have a feeling of ownership in a new Senior Center.
- COA members were polled as to which site they would ideally like to see considered for the new Center unanimous vote was for Cassidy Farm
- Elizabeth noted that she felt having everything located in or near VMB would be ideal she felt at this time it looks like Cassidy Farm is the best option. She also suggests that Patty link the proposed programs from the survey study be assigned to each room on the Cassidy Farm proposal to show that we would definitely have enough room to offer proposed programs and that we will indeed need more room.. Patty will do this and forward to Diane and Wayne. This idea met with unanimous approval by the Board.
