Treasurer's Report

- Formula Grant should be available within the next week. We are currently running at a 15K deficit
- MCOA dues are paid 1X/year in July

HESSCO Report

- Focused on 2021 figures numbers are down due mostly to shortage of staff although HESSCO is offering sign on bonuses
- They are exploring Grief Counseling person to work with COA
- Millis is looking at Town wide social worker to work with Police, Fire depts, schools and Board of Health & COA

Outreach Report:

- HESSCO offering Meals on Wheels, Med alerts system and laundry help are the only things available from them at this time
- Friends Indeed have offered to help seniors with trash take out as well as transportation to cancer radiation treatments refer to their Facebook page
- 135 unduplicated and 425 duplicated in January as compared to 94 unduplicated and 227 duplicate January 2021
- Busy helping with Fuel assistance, food stamps and computer help
- Discussion about changing the name from Senior Center to Adult Center to make it more inclusive of younger seniors -put an article on Millis Social Service this publicity is important to our goal for a new Center. Chris will check with Jim to see how to accomplish this

Director's Report:

- Looking at new flooring for Rm 18 and new freezer has samples on flooring and working with a contractor on purchase of best freezer for our use
- Program on Proactive planning had 10-12 people attendance
- Elder Dental had 8 attendees information is available on the COA website
- Chris suggested that she would put out a flyer and article in the Glen newsletter regarding the offerings of the Sr Center as the Glen residents want to be involved. Patty will work with the news person at the Glen to make sure our info is included in their future newsletters.
- Our newsletters are sent out every month except once for Jan& Feb and once for July & August
- Bert and Patty are working on the budget for next year and should be completed at the end of next week no increase expected from last year but we will ask for a Program/Volunteer Coordinator position.

- Rochelle Bunt started this week as the new transportation coordinator
- Bert inquired as to an update on Food Pantry offering to the Sr. Housing?? None as yet
- We still do not have the handicapped plate for the new van
