HESSCO Report

- Presented by Elizabeth
- "12 cities and towns are in our group and most funds come from the State (15% only from the US government) with 35K earmarked for Millis in May.
- They will be moving from Sharon to Walpole to save consolidate space and save money.
- 291 people are waiting for services over all the towns they serve due to labor shortage in all agencies that HESSCO deals with. There will be no July or August meeting for HESSCO.

Outreach Report presented by Patty

• We have seen 10 individuals 63 times all under 60 years old in the past month including disabled persons in need of housing and transportation, facing homelessness. Debbie Sands interviewed with the Millis Medway news yesterday to outline the help she is able to give to residents

Director's Report:

- Patty will be out of work for 8 weeks due to upcoming back surgery.
- Will work with the Board to discuss coverage for this period

Chairmen's Report

- Helen presented Madeline Yusna's offer to broadcast an independent coverage of all questions and answers worked on by the COA Elizabeth noted that she took count of last Focus Group meeting which showed that 3 voted for the VMB, 6 for Cassidy w/gym and 9 do not build anything
- Meredith noted that her breakfast group want 1 story building
- Brooks noted that it seems that the architects as well as the PBC are pushing the addition to the VMB

- Ellen noted that the cost presented will use the prevailing wage which is very high and that LEAD signifies "energy efficient". All we need to approve is the senior vote she will get specific figures.
- Brooks asks if Holliston is interested? Ellen has a meeting schedule next week with the Holliston Select Board member (Hein) to discuss.
- Patty will talk to Madeline to set a date for filming after the last Focus Group meetings
- Meredith will bring another application to the Select Board (the original was lost or misplaced). Helen will check with her to make sure that this one is processed properly
