Meeting was called to order at 9:00 AM

- The purpose of the meeting was to discuss how to proceed over the next two weeks coming up to Town Meeting on November 10th. After discussion it was decided we would ask the Select Board to withdraw Article 8 from the November 10th meeting. Without the full support of the COA, Planning Board, Finance Committee and Select Board we thought it best to wait until the May Town Meeting, and in the interim reengage with Abacus on alternative plans, explore the possibility of any grants, and coalesce around a plan all 4 boards and the citizens of Millis will support. Chris McCaffrey voted for this with reservation (she would have preferred to have the vote at the November Town Meeting).
- We have to keep in mind that in addition to Town Meeting in May we also have to get this question on the election ballot for the May town election.
- Wayne is going to send his response to the Finance Committee on the costing emphasizing that the \$16M cost for a 15,000 square foot building is in-line with all of the other Sr. Center projects currently under consideration or construction in Massachusetts.
- There is a Finance Committee pre-town meeting November 2nd at 7:00. Wayne plans to attend that meeting to explain the costing, and the COA was asked to support him at that meeting.
