## PROPOSED MCEOD EXPANSION BYLAW AMENDMENTS, PUBLIC HEARING

The public hearing was opened at 7:30 p.m. by Ms. Riley On a motion made by Ms. Riley, seconded by Mr. Yered, it was voted unanimously to waive the reading of the public hearing notice. By Roll Call Vote: Nichols – aye; Riley – aye; Yered – aye; Raut Chhetry – aye; Handel – aye; Guerrero – aye.

Ms. Riley presented the proposed bylaw amendments. The purpose of the Millis Center Economic Opportunity Overlay District (MCEOD) bylaw, passed in May of 2004, was to (1) enable the redevelopment of the downtown commercial area into a mixed-use village center, (2) to provide alternatives to single family housing, and (3) promote economic development of the town center. The MCEOD Overlay does not change and/or delete the underlying zoning district. Instead, it provides commercial property owners mixed-use options in addition to those uses allowed in the underlying zone, she said.

This amendment to the existing bylaw does not change any portion of the current MCEOD bylaw district; it simply extends the Overlay District to include twenty-five (25) additional commercial parcels. The infrastructure for this potential extended foot traffic already exists in this portion of Main Street and Pleasant Street in the form of streetlights, sidewalks and crosswalks. This amendment will allow only the C/C-V parcels located in the Pleasant Street, Main Street, Hammond Lane and Farm Street area the additional use options. The extension of the MCEOD as stated above helps to "level the playing field" for this part of Town, Ms. Riley stated.

Mr. Merrikin of Legacy Engineering spoke in favor of the amendment, stating that this will "tend to help support businesses that may be struggling."

By Roll Call Vote: Nichols – aye; Riley – aye; Yered – aye; Raut Chhetry – aye; Handel – aye; Guerrero – aye.
