Millis Transfer Station Regulations 2023-2024

Location: Environmental Drive (off Water Street, east of the DPW Facility).

Regular Days and Hours of Operation:

Saturday: 8:00 - 11:00 AM and 12:00 - 3:30 PM Wednesday: 8:00 - 11:00 AM and 12:00 - 3:30 PM

2023 Summer Hours of Operation (June 7th - August 30th):

Saturdays: 8:00 - 11:00 AM and 12:00 - 3:30 PM Wednesdays: 8:00 - 11:00 AM and 12:00 - 6:45 PM

<u>Permits:</u> Each vehicle that uses the Transfer Station must display a Transfer Station Permit permanently affixed to the lower driver's side of the windshield. Permits are renewed annually and expire June 30th. <u>Permits are non-transferrable and non-refundable</u>. Permit Prices: 62 Years of Age & Over: \$30.00

Under 62 Years of Age: \$85.00 Additional permits for other vehicles at the same residence are \$8.00 each.

Lost, Misplaced or Replacement Permits are \$10.00 each.

Recycling:

<u>Paper:</u> All recyclable paper items including newspaper, magazines/catalogs, cardboard (flattened and cut into no larger than 2' x 2' pieces), junk mail, but excluding paper napkins, tissues and paper hand towels. No cat papers or paper products which have been contaminated with food residue; pizza boxes; egg cartons.

<u>Co-mingled Materials:</u> Includes all rinsed plastic jars, bottles and tubs numbered 1 through 7; unbroken, rinsed glass bottles and jars; steel/aluminum cans/foil. Materials not accepted include plastic containers previously used for motor oil or other chemicals; plastic bags; aerosol cans; light bulbs; window glass; ceramic dishes; mirrors.

Scrap Metal: Metal chairs; storm doors; bicycles, etc. Non-metallic parts should be removed.

Books and Clothing: May be deposited in the appropriate bins.

<u>Leaves</u>, <u>Brush and Tree Branches</u>: Leaves should be emptied into the compost pile, branches of less than two inches in diameter shall be deposited in the designated area. Brush should be cut into lengths not exceeding eight feet. No logs. No commercial brush and leaves will be accepted at the Transfer Station.

<u>Tires, Automobile Batteries, Water Heaters and Oil Tanks:</u> may be disposed of at Conigliaro Industries, 36 Fountain Street, Framingham, MA 01702. Hours: Monday – Friday 7:00 AM – 4:30 PM.

Batteries: - Rechargeable are recyclable (camcorders, cell phones, etc.). Alkaline should be disposed of with household rubbish.

Computers, Monitors, Televisions, Stereo Equipment, and Microwave Ovens – Are accepted at the Transfer Station for recycling at a rate of \$21.00 each. Limit 2 per Transfer Station permit per day. Fees can be paid by check or money order to the attendant upon disposal.

<u>Large Items:</u> The disposal fee for large items - washing machines, dryers, stoves, mattresses, couches, stuffed chairs, etc. is \$21.00. Fees can be paid by check or money order to the attendant upon disposal.

<u>Bulky Rigid Plastic Items:</u> (Toy Cars, Toy Houses, etc.) are accepted at the Transfer Station. The disposal fee is \$21.00 per item. Fees can be paid by check or money order to the attendant upon disposal.

Waste Oil, Propane Tanks, Air Conditioners, Refrigerators, Construction & Demolition Materials, Creosote-soaked Timbers, Sheetrock, Clean Gypsum Wallboard, Shingles and Wood are NOT accepted.

<u>Blue Bags:</u> All refuse not recycled must be placed in a specially marked Town of Millis blue bag, bags are available for purchase at the Customer Service areas at Roche Bros., Namaste and Richdale Foods and should be placed in the refuse compactor at the Transfer Station. Large bags are \$1.75, small bags are \$1.25.

The Attendant in charge shall be obeyed by all users of the Transfer Station at all times, and materials must be deposited in accordance with his instructions or, in the absence of his specific instructions, as directed by signs. The Attendant in charge is authorized to require reasonable and satisfactory evidence concerning the origin of refuse contained in any vehicle, and he is further authorized, upon failure to satisfactorily establish the origin of refuse as being generated in Millis, to prohibit the use of the Transfer Station to the operator of said vehicle. Whoever violates rules and regulations of the Transfer Station facility will be warned of possible suspension of his/her permit to use the facility as follows: first offense - written warning; second offense - hearing before the Select Board.
